Current Month updates:

Items 2, 7, 8, 9 & 11 were discussed with NCC officers at a recent meeting and should be addressed in the coming months.

Other Issues dealt with this month:

The Clerk has reported parking issues on The Griffin at school end times, brambles growing out of the bottom of the hedge on the Griffin, and that attempted break-ins in outbuildings on the Griffin have been made recently.

The Clerk has also assisted the neighbouring community council of Draethen, Waterloo and Rudry with finding out the authority responsible for maintaining the road bridge to Draethen from the A468. The bridge should be maintained by Caerphilly CBC. Closer working links with DWR CC is hoped for.

Risk assessments have been written and work has been carried out to enable both Rhiwderin Community Centre and Graig Hall to open up safely for regular users. Unfortunately for the time being, neither Centre will be taking bookings for ad-hoc users such as Birthday parties and single weekend bookings.
