Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

Auditor General's report

Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis for Qualification

Accounting statement

I am unable to conclude whether or not the Accounting Statement properly present the Council's receipts and payments and financial position:

- The Council's accounting records (bank reconciliation) does not reconcile to the annual return.
- The Council's annual return for the current year is arithmetically incorrect, the Council was unable to provide an explanation for the errors.
- The Council has not provided a complete explanation for significant variances within the year.
- The Council has not provided supporting explanation for its increase in borrowing and we are unable to conclude as to whether this borrowing was approved.

Annual Governance Statement

In my opinion, the Annual Governance Statement is inconsistent with the Councils governance arrangements in the year:

- Assertion 1 – approval of the accounting statements. The Council has not had proper arrangements for the preparation and approval of the accounting statements for the current year. The Council did provide an approved annual return for audit.

Other matters arising and recommendations

There are no further matters that I wish to draw to the Council's attention.


